Dr Balakrishna Pisupati is currently the Chairman of National Biodiversity Authority. He was the Head of Biodiversity, Land Law and Governance Unit of United Nations Environment Programme's Division of Environmental Law and Conventions (UNEP-DELC), based in Nairobi, prior to joining the NBA. At UNEP, he was managing UNEP's biodiversity-related environmental conventions such
